Please read all information regarding the pageant and your division. All contestants must be legal residents of Albemarle, Buckingham, Fluvanna, Greene, Louisa, Madison, Nelson and Orange Counties and the City of Charlottesville. Proof of residency may be requested.

The divisions for the Dogwood Festival Pageant are as follows: Wee Miss (ages 1-3), Tiny Miss (ages 4-6), Little Miss (ages 7-9), Pre-Teen Miss (ages 10-12) and Teen Miss (ages 13-15).

Teen Miss interviews will be held the day of the pageant from 9:00am-10:00am. Contestants need to arrive at 8:45am. Stage practice will be after interviews.

Wee Miss, Tiny Miss, Little Miss, and Pre-Teen Miss need to arrive at 9:45am. Stage practice will begin at 10:00.

Please arrive on time. The pageant will begin promptly at 11:00am and if you are not in line, you will not participate.

Wee Miss, Tiny Miss, Little Miss, and Pre-Teen Miss will need a casual wear outfit and a church dress or pageant dress. Clothing must be age appropriate and in good taste. Wee Miss, Tiny Miss, and Little Miss may not wear make up. Pre-Teen Miss may wear blush, mascara, and lip gloss only. This is not a glitz pageant. All contestants will be introduced. Tiny Miss, Little Miss, and Pre-Teen Miss will be asked an on stage question from their bio during the church/pageant dress competition.

Teen Miss will wear a dress or suit to their interview. Hemline may not be more than 3 inches above the knee. Teen Miss will need a casual wear outfit and an evening gown. Clothing must be age appropriate and in good taste. Teen Miss may wear age appropriate make up. Teen Miss will do their introductions during the casual wear competition. Teen Miss will be introduced during the evening gown competition. Teen Miss will be asked an on stage question from their bio during the evening gown competition.

Wee Miss, Tiny Miss, Little Miss, Pre-Teen Miss and Teen Miss may submit a photo for the photogenic competition. Photos may not be larger than 5X7 and may not be framed. Photos must be age appropriate. All photos need to be picked up at the conclusion of the pageant.

- Wee, Tiny, Little, and Pre-Teen Miss will be required to participate at 2012 Dogwood Festival activities.
- Wee, Tiny, Little, and Pre-Teen Miss may not hold another local county title while holding a Dogwood Festival Pageant title.
